Preface

The Rose Institute of State and Local Government is embarking on a grand study of California's Chinese Americans. This study, which is being overseen by Chinese American Rose Institute Board Members Lilly V. Lee and Harold T. Yee, will probe into one of the oldest, largest and fastest-growing ethnic communities in the state. Ultimately, the Rose Institute's demographic, economic and political research on Chinese Americans in California will serve as a valuable resource, resulting in a number of publications.

One of the first tasks the Rose Institute sought to accomplish in the Chinese American project was to identify and locate current research (from 1976 to the present) on Chinese Americans. Such a search would provide a network of scholars to consult over the course of the study, information about particular topics of interest in the Chinese American community and a resource tool for those interested in learning more about Chinese Americans. The result of the search is this survey.

Research for this survey was conducted primarily at the University of California at Berkeley's Asian American Studies Library. The head librarian, Mrs. Wei Chi Poon, has compiled an extensive Chinese American Research Collection for the library that includes Chinese American documentation and publications in Chinese and English. The library falls under the auspices of UC Berkeley's Department of Ethnic Studies, Asian American Studies Program, which is coordinated by Professor L. Ling-chi Wang.

A comprehensive reference work entitled *Asian American Studies: An Annotated Bibliography and Research Guide*, by Dr. Hyung-Chan Kim of Western Washington University, was also regularly consulted in the search for materials relevant to the California Chinese American community.

Over five hundred books, journal articles, research projects and doctoral dissertations are cited in this text. Though the Rose Institute study is only concerned with Chinese Americans in California, works regarding Chinese Americans in general, Asian Americans in California, and Asian Americans in general were also included to provide additional information for a broader perspective. These works were categorized into various subject areas. Although many of the titles could fit in any number of categories, each title was given only one or two different subject headings.

Any significant work that is not listed here was not purposely omitted. There simply was a large body of work to check through. We apologize for this and would be happy to amend this survey with additional information.

The last sections of this survey lists various academic journals featuring research on Chinese Americans in California and a number of institutions where Chinese American Studies scholars can be located. An author index to the main survey section is also featured at the end. Authors with at least three citations in this text are listed in the index of frequently cited scholars with their current affiliation and specialty area, if known.

As a Chinese American in California, I am grateful for the opportunity to learn more about my heritage. I am especially grateful for those who want to teach me; many of those individuals are found in the following pages.
